STUDENT GRIEVANCE PROCEDURE

Computer Career Center a Division of Vista College provides a prompt and equitable process for resolving student grievances. The procedure is available to any student who believes that a school decision or action has adversely affected his/her status, rights, or privileges as a student. All grievances must be submitted in writing. Once a final decision has been made, the complainant will receive an official copy outlining the resolution. Students with a grievance must first make a reasonable effort to resolve the issue on an informal basis with faculty or administrative personnel if the issue is not resolved to the student's satisfaction the Campus Director shall review the grievance with all parties concerned.

The School Director's decision is considered final at the institutional level. If the student is still not satisfied the student may direct a grievance to the School President for final resolution.

If after all grievance procedures have been followed a resolution has not been achieved, at the institutional level, students in Associate of Applied Science degree-granting programs may submit grievances to the Commission of the Council on Occupational Education (COE), 7840 Roswell Road, Bldg 300, Suite 325 Atlanta, Georgia 30350 and/or the Texas Higher Education Coordinating Board (THECB), PO.
